# What is *Gift Aid*

If you are a UK tax payer, you can make every £1 you give – or have given – worth 20p more, just by telling us. This is because the government's Gift Aid scheme allows MWH's to reclaim tax on donations. This means that you can make an even bigger difference **at no extra cost to you!**

## *Find out more about Gift Aid*

For your donations to be eligible for Gift Aid you must pay an amount of income tax and/ or capital gains tax for each tax year (6 April one year to 5 April the next) that is at least equal to the tax that all charities and CASCs reclaim on your donations in the same tax year.

If you pay higher rate tax you can claim further tax relief in your Self Assessment tax return.

## *How to Gift Aid your donation*

If you make a donation, you can tell us whether you want to Gift Aid your donation simply by ticking the box on the form.

If you prefer to send a cheque in the post, please include a **Gift-Aid declaration(available on our website or upon request).**
